# **Chiefs Report to the Board of Commissioners**

#### Miscellaneous

- We are still under an excessive heat watch until Tuesday, which includes a red flag warning until this evening. All SCFD5 resources are in service.
- Smokey Bear project is still coming along, and we are waiting for parts to include cleanout vaults and drainage parts. Bulk subgrade materials have been delivered.
- Auto Extrication training was held at Station 51, with 19 personnel gaining hands on experience. An instructor was brought in who taught both basic and advanced maneuvers.
- Braven Auto Salvage of Lake Stevens brought 8 cars for personnel to cut up, at no cost to the District.
- The District provided the Volunteers of America a letter of support for them seeking grant funds to expand the Mental Health Co-Responder program. This grant had a short turnaround, but the aim is to hire two additional Mental Health Responders geared more toward overdose response, treatment and follow up.
- There was a blood drive at the station on Friday, hosted by Sultan High School HOSA students and a CPR/First Aid class on Saturday with 30 participants. Our staff instructors received multiple positive remarks about the professionalism of their instruction. Many of the participants in this class were reached through our "Take 10" CPR demos during Shindig and other outreach events.
- The first meeting for the purpose of investigating a Local Health and Welfare Trust is scheduled for this Thursday, and the agreement is on the agenda for approval.
